Coordinate meetings and PRA exercises with the local village communities and organize stakeholder consultations. Collect geospatial data / take up ground-trothing in selected areas of Keibul Lamjao Conservation Area, Manipur. Desktop review of literature related to biodiversity of Keibul Lamjao Conservation Area, Manipur. Liaison between the field officials of Manipur Forest Department and Project Team of C2C.
