5. **Warranty:** You are required to give a warranty for a minimum period of **one year** from the date of satisfactory supply of the equipment. If during warranty period, the equipment supplied fails to give satisfactory performance and found defective, you will rectify the defect within a reasonable time; failing which the equipment should be replaced with new one(s) without any extra cost.
6. **Prices:** You should quote your rates on a fixed price on FOR, WII, Dehradun basis.. The taxes, if any should be clearly mentioned. The prices should be quoted only in Indian Rupees.

mentioned above, their offer will not be considered and shall be summarily rejected by the Institute.

12. **Payment:** Payment shall be released on bill basis after entire supply and inspection and acceptance of the equipment in good condition
13. **Delivery:** Agency would be required to supply the equipments within a period of four weeks from the date of issue of supply order, if placed with your firm. The delivery address is Wildlife Institute of India.
14. **Penalty:** Penalty @ 0.5% per week will be charged for late supply subject to a maximum of 5% on the amount of equipments which have been supplied late.
