Terms & Conditions:

1. The above requirement is on quarterly basis. The expected approximate quantity may differ from time to time as per the requirements. The bill will be raised by the agency on monthly basis. The bill details will be scrutinized by the project PI/Co-PI and accordingly the payment will be released.
2. For above an Annual Rate Contract for period of one year will be entered with the selected bidder.

4. High standard of quality will be maintained. All supplies will be supervised by a representative of WII - Dr. Sutirtha Dutta (Co-PI).
5. The specifications of the quoted items should be strictly as per technical specifications mentioned above.
6. The supplier should indicate full details of the item and submit complete details, without leaving any scope for ambiguity. The supplier must ensure that the quotation submitted is in accordance with the requirements/specifications of WII.
7. Offer should be valid for a period of 12 month from the date of submission of quotations.
8. **Prices:** You should quote your rates on a fixed price on FOR, Jaisalmer basis. The taxes, if any should be clearly mentioned. The prices should be quoted only in Indian Rupees.
9. You may submit your rates/offer for the item in the following format only. You may use separate sheets, if required.

10. The bidder is required to clearly mention that they agree to all the terms and conditions of this quotation and it should be given on their printed letterhead indicating GST Registration, FAX, Email, Telephone numbers, etc.
11. Offers of those firms will only be considered by the Institute, whose bids are meeting all the parameters given for the above required items. If any of the given parameters does not meet

the required specifications as mentioned above, their offer will not be considered and shall be summarily rejected by the Institute.

12. **Comparison of Rates:** Comparison of Rates shall be made after adding the taxes etc. (if any) and given in above Table.
13. **Payment:** 100% payment shall be released on bill basis after entire supply and inspection and acceptance of the above items in good condition.
14. **Delivery:** Agency would be require to supply the items as and when demand is raised by the Project Co-PI.
15. The above quantity of the items are approximate, the same may be reduced or increased at the time of issuing demand order(s), depending upon the requirement of the Institute.
16. The Institute reserves the right to accept or reject any of the quotation straightway without assigning any reasons.
