Sub:- REQUEST FOR INFORMATION UNDER RIGHT TO INFORMATION ACT, 2005 - regarding

Sir,

I would like to draw your kind attention towards your kind letter No. A/2-1/2007-WII (Vol. VIII: 2014-15) dated 23 Feb 2015 in response to my RTI application dated 10th/12th Jan 2015.

1. A span of three months has gone by, hence, I do hope the decision taken by the Competent Authority within the purview of prevailing Rules & Regulations, orders & Instructions, Acts and so on has come out by now with a fruitful result regarding grant of gratuity. As per your kind letter quoted under ref, a further communication to this effect is awaited.
2. Contrary to my above expectation, I am left with no option but to seek the following information for which I request you yourself once again to kindly arrange to supply me the same under the provisions of RTI Act, 2005:-

- (a) Definition & grounds on which gratuity is granted
- (b) Date and month of the year in which decision taken by the Competent Authority
- (c) A recorded copy of file notings related to decision taken
- (d) Extract/copy of the Rules & Regulation, Orders, Acts, Legal opinions etc which debars me from getting the grant of gratuity even after rendering more than 22 yrs contractual service with the WII

I shall be grateful if an early & favorable information is provided to me in the larger public interest of mine in particular and other contractual employees, in general.
