S.No.	Clarification as asked by Mr Nalin Khanduri	RESPONSE
1.	Please explain the meaning of *LESS EXPERIENCE* for my candidature as mentioned in your letter.	<p>As per advertisement for the post of Administrative Officer, the essential qualification (EQ) required was "Graduate Degree with 15 years of experience of handling administrative/ training/ accounting responsibilities with good service record in reputed organizations"</p> <p>The applicants' who had experience less than the required experience of 15 years have been considered as of "Less Experience".</p> <p>In case of Mr Nalin Khanduri, the Screening Committee could find only 10 years and three months of experience from 15<sup>th</sup> November 2004 to 07<sup>th</sup> October 2012 and 08 October 2012 to 31<sup>st</sup> January, 2015 respectively. Hence the candidature did not meet the EQ criteria and was not shortlisted .</p>
2.	Please advise what was the mode of communication used to intimate the non qualified candidates that their application has been rejected, the application form had all the details of residential address, mobile number, email ids.	As per the routine procedure adopted, only shortlisted candidate were intimated and called for skill-cum-proficiency test.
3.	When the application was rejected in the initial level it than why your office had accepted the demand draft of Rs 1000/- from the candidates and for what purpose.	Application fee of Rs. 1000/- is a mandatory requirement with the application, irrespective of whether the candidate is shortlisted or not.

Applications from eight candidates were received out of which two were shortlisted for the Skill-cum-proficiency test.
