Sir,

This is in reference to the RTI application dated 03.02.15 filed with the CPIO, Wildlife Institute of India (WII), Dehradun (**Annexure A-1**). In this connection, I would like to bring to your notice the following facts:

1. That, even after 30 days of my application being filed with the CPIO, Wildlife Institute of India (WII), Dehradun, I have still not been provided with the desired information thus grossly violating the statutory stipulation under the Act for providing information within 30 days.
2. That, **Section 7(1) of RTI Act, 2005** states "*Subject to the proviso to sub-section (2) of section 5 or the proviso to sub-section (3) of section 6, the **Central Public Information Officer** or State Public Information Officer, as the case may be, on receipt of a request under section 6 shall, as expeditiously as possible, and in any case within thirty days of the receipt of the request, either provide the information on payment of such fee as may be prescribed or reject the request for any of the reasons specified in sections 8 and 9: Provided that where the information sought for concerns the life or liberty of a person, the same shall be provided within forty-eight hours of the receipt of the request*".
3. That, **Section 7(2) of the RTI Act, 2005** states "*If the **Central Public Information Officer** or State Public Information Officer, as the case may be, fails to give decision on the request for information within the period specified under sub-section (1), the Central Public Information Officer or*

State Public Information Officer, as the case may be, shall be deemed to have refused the request”.

4. That, **Section 7(6) of RTI Act, 2005** states “*Notwithstanding anything contained in sub-section (5), the person making request for the **information shall be provided the information free of charge where a public authority fails to comply with the time limits specified in sub-section (1)**”.*
