**Sub: Appeal against denial of information under RTI Act 2005**

1. I had asked for information under the RTI Act, on four points vide my letter to the PIO, Wild Life Institute, No: CFGD/RTI/03/88 dated 22<sup>nd</sup> June 2015. (Copy Attached)
2. No information requested in 1(a) was provided.
  - a. Photocopy of the original letter written by DFO Mussorie to Wild Life Institute was not provided, nor other letters related to it.
  - b. File notings with reference to the letter were also not provided.
  - c. Letter authorizing the Wildlife Institute officer to conduct the field trips was also not provided.
3. For information requested in 1(b), (c) and (d):
  - a. I had asked for information regarding field trips undertaken to write report mentioned in letter no: DWII/Misc/03/2014 Dated 3<sup>rd</sup> December 2014, these were undertaken in the months of July – September 2014 to study elephant movements in the area and in which local people and field staff was interviewed. No information for the same was provided. I was however provided with details of a field trip undertaken to study river bank enforcement work in October 2014, which I had not asked for. This amounts to denial of information. Therefore you are requested to please take further necessary action in the matter and direct the PIO to provide relevant information.
