

- (i) Study the order of Hon'ble High Court of Uttarakhand dated 26<sup>th</sup> May, 2015 in Writ Petition (S/S) No. 1580 of 2011.
- (ii) Suggest follow up actions required for implementing the directions of the said order.
- (iii) Prepare a brief note for Ministry of Environment, Forests & Climate Change (MoEFCC) clearly specifying what actions are required at their end.

(iv) Deal with all matters arising out of the said Court order.

(v) The Committee may co-opt special invitees and seek legal opinion, as may be required.

(2) The Committee will submit its written report, complete in all respect including covering letter(s) on or before 9<sup>th</sup> June, 2015. The above matter will be given highest priority considering the time frame given by the Hon'ble High Court for implementing its orders. A copy of the judgment dated 26<sup>th</sup> May, 2015 of Hon'ble Uttarakhand High Court is attached.

**Sub: Recommendation for Implementation of Decision of Hon'ble High Court of Uttarakhand in Writ Petition No. 1580 of 2011 (S/S) in case of M.D. Gupta V/s Wildlife Institute of India & Others – reg.**

Ref: Office Memorandum No. WII/ADM/2011-12/017 (Part) dated: 5th June, 2015 (Annexure-1).

The implementation/compliance of decision/order of the Hon'ble High Court of Uttarakhand at Nainital dated 26<sup>th</sup> May, 2015 in Writ Petition No. 1580 of 2011 (S/S) in case of M.D. Gupta V/s WII & Others (Annexure-2) require following actions:-

- (i) To prepare and finalize the seniority list of all the Class III employees working in the Institute, on different posts giving the notional promotion to the petitioner from the date on which he became entitled on the post of his next gradation and so on.
- (ii) The provision of the present incumbent on the post of Hindi Translator remaining in the feeder channel for promotion to the post of Section Officer has been quashed. It implies that Smt. Baljeet Kaur require to be reverted back to her previous position. This action is also required because inter alia the order has also held her promotion to this post de hors the rules.
- (iii) It has been ordered to take appropriate steps to revert back those respondents who have got illegal promotions de hors the Rules.

Pursuant to and in compliance of the Order of the Hon'ble Court, the record required to be examined was from year 1985 to till date. The Committee perused and examined the record and recommends as under –

- (1) **Notional promotion to the petitioner from the date on which he became entitled on the post of his next gradation and so on.**

That Shri M.D. Gupta was recruited as Lower Division Clerk in year 1985 on Direct Recruitment basis. The Recruitment and Promotion Rules of the Institute vide which his service conditions were governed placed him at the level of O(1) and prescribed qualifying length of service of five years for promotion from Level O(1) to Level O(2). Further, the Rules require service length of five years from Level O(2) to O(3), of eight years from the Level O(3) to O(4), of five years from the Level O(4) to O(5). A copy of the old Recruitment Rules of 1986 is placed at Annexure-3.

Thus, Shri M.D. Gupta becomes entitled to promotions on the above levels as under:

The Order of the Hon'ble Court mandate notional promotion to Shri M.D. Gupta from the date on which he became entitled on the post of his next gradation and so on. Presently, Shri M.D.Gupta is positioned at level O-2. As shown in above Table he attains the O-5 level on 25-01-2008. However, the Academic Officer position was filled up by Shri Ashutosh Sharma. The incumbent (Shri Ashutosh Sharma) superannuated on 31.12.2009 and the post of Academic Officer was vacant and Shri M.D. Gupta attains entitlement on this post on 01.01.2010. The recruitment rules of the Administrative cadre were amended in year 2007 (**Annexure-4**) and further amendment in the pay scales of Administrative Officer/Academic Officer and Assistant Grade I were made vide Institute's Circular No. A/1-3/XLVII/GB/WII dated 19.11.2009 (**Annexure-5**). As a result, this level is now in three hierarchical sub gradations namely of (i) Finance Officer (PB 2: GP 4600), (ii) Academic Officer (PB 2 : GP 4800) and (iii) Administrative Officer (PB 2 : GP 5400). The rules do not provide for any residency on these three sub gradations for promotions and thus promotion from Finance Officer to Academic Officer to Administrative Officer is only vacancy based. The position of Administrative Officer is held by Shri P.K. Aggarwal. Therefore, pursuant to and in compliance of Order of the Hon'ble Court, the notional upward movement of Shri M.D. Gupta can take place upto the position of Academic Officer. Accordingly, it is recommended to issue promotion orders on notional basis in respect of Shri M.D. Gupta to level of Assistant- I (earlier level of O-3), Section Officer (earlier level of O-4), Finance Officer (earlier level of O-5) and on regular basis to the Post of Academic Officer (earlier level of O-5) with immediate effect.

(2) The promotions that were impugned in CWP No. 1580 of 2011 (S/S) and in respect of which the order of Hon'ble High Court is sought to be implemented on basis of these recommendations involve scrutiny of the erstwhile recommendations of the Departmental Promotion Committees of the Institute held on 17.11.1993, 29.06.1994, 17.08.1999 and 03.10.2000 **Annexure 6 colly.**

(4) In the event of implementation of above recommendations in compliance of Order of Hon'ble High Court , certain further actions will be required on immediate basis -

- (i) The reversion of employees will leave vacancies in the upper levels of cadre and for smooth functioning of the Institute, the DPCs for filling up of vacancies will have to be convened at an early date. Since the reversions will take place with effect from the issue of Orders in this regard, the promotions henceforth will take place following the Recruitment Rules of 2007 and as amended from time to time.
- (ii) It is obtaining that Shri A.K. Dubey will revert back to the post of Hindi Translator which presently is an isolated post. Presently, career progression of such posts is governed under MACP Scheme. However,
