Mode of Selection and other conditions:

- 1. The selection of the candidates will be in accordance with the performance in the interview and in order of merit as decided by the Interview Committee. All original documents should be produced at the time of interview. The decision of the Institute's Committee in all matters relating to eligibility, work experience, acceptance or rejection of application will be final and binding on the candidates and no enquiry or correspondence will be entertained from any individual.

- 3. Application forms needs to be typed according to the prescribed format and must be accompanied by: (a) Scanned copies of educational qualifications, and

(b) Scanned copies of experience letter/ certificate, failing which applications will not be considered.

4. The applications received after the deadline will be rejected by the Institute.

- The shortlisted candidates will be notified (through email and website notification) for online personal interview by 15th April 2021. The online interview will be held on 19th April 2021 from 1000 hrs onwards.
- 6. At the time of verification of original documents, if it is found that an attempt has been made by the applicant to wilfully conceal, misrepresent or canvass the facts, his/her candidature will not be considered.
- 7. The positions advertised are purely temporary/ contractual for the project period only and will stand abolished after completion of the project.
