2. The presiding Officer and every member of the WII-IC shall hold office for three years from the date of this notification. The Presiding Officer may opt for a student member as and when and if required.

3. As provided under Rule II(3) of the Act, for the purpose of making an inquiry under SUB-Section (1) of this Rule, the WII-IC shall have the same powers as are vested in a Civil Court, under the Code of Civil Procedure, 1908 when trying a suit in respect of the following matters, namely:-

- (a) Summoning and enforcing the attendance of any persons and examining him/her on oath;
- (b) Inquiring the discovery and production of documents; and
- (c) Any other matters, which may be prescribed.
