Gain Global Perspectives on Natural and Cultural Heritage







Course Background

The growing importance of heritage conservation as an academic subject and a management mandate in National and International agendas indicates a need for professionals to be trained in its approaches. While heritage is broadly classified into the two main groups of natural and cultural heritage, the linkages between the two domains is highly recognizable. The **Certificate Course in Heritage Management (CCHM)**, designed to build capacity in heritage conservation with a focus on natural heritage, will equip the participants with a functional understanding of heritage conservation and the ability to incorporate the same in the management of the heritage sites. The course, with a duration of four weeks, will provide an **opportunity for inter-disciplinary learning** and will help share the expertise of Wildlife Institute of India (WII) in the field of wildlife conservation and natural heritage management.





About the Course

This 4-week fully residential programme beginning 12th August, 2024 will be conducted at the biodiverse and forested campus of WII in Dehradun. The course will have a maximum capacity of 15. And, has been designed to impart training in the concepts, theories and practices implemented in the multi-disciplinary field of heritage conservation. The course is also designed, through the prism of heritage, to further the understanding of applicable United Nations Sustainable Development Goals. Further, the participants will be trained in practical management of heritage and help understand the whys' and how's of Management Plan prescriptions, and learn techniques for implementing them. The course will include a three-week lecture based session and one week field tour to a natural heritage site. The medium of instruction in the course will primarily be in English.



Eligibility

The course is open to Indian nationals who are currently involved in managing natural heritage sites and are likely to manage such sites in future. Target participants include forest and wildlife department officers of ranks of the Assistant Conservator of Forests (ACF)/ Deputy Conservator of Forests (DCF), or their equivalents from other departments in India *viz*. Culture, Tourism, Archaeology, Geology, Railways.



Maximum age limit is 45 years.

Candidates must be physically fit to be able to undertake the field tours and travel.

Course Content

The four-week course will begin with a module on the concepts and conventions of heritage providing a base for the trainees to build their understanding better. The intent would be to understand the principles, philosophies, and history behind the heritage conservation movement with a focus on international conventions and the emerging domain of nature-culture linkages. In addition, two other modules – one on heritage management and the other on heritage interpretation – will be conducted. The former will guide the trainees to acquire and apply methods used for natural heritage management through theory, practical and detailed case studies. The latter will see the trainees apply heritage interpretation tools in planning and management of sites. Following the three working weeks of lecture based sessions the course will conclude with a five-day field tour to heritage sites of significance to understand on ground heritage site conservation and management.

The cost of the course (incl. accommodation, food and tours) will be borne by WII-C2C. Candidates will bear their own travel expenses for arriving at and departure from WII Dehradun.
