

1. PREAMBLE

Wildlife Institute of India (WII) regularly receives request from candidates both within and outside country to be engaged as a 'Volunteer' in any of the ongoing research projects or cell activities. These requests are aimed at gaining practical experience in the chosen field by the candidate. The increasing number of such requests appears to be the result of limited number of positions offered under the 'Internship Programme', while there is increasing number of people interested in wildlife research and conservation. This document outlines the rules and regulations to engage interested candidates as volunteers in WII.

2. VOLUNTEER

Any qualified person(s) who offers voluntary assistance to any research, academic and training activities of the Institute in lieu of exposure and experience in such activities, and thereof, does not entitle to any position, either temporary or permanent in the Institute. The services offered will not attract any monetary compensation.

3. STATUS

The 'volunteer' opportunity is purely for gaining exposure and experience in any of the ongoing research projects or cell activities of the Institute and does not qualify to produce mandatory requirements such as 'Summer Training Project' or 'Dissertation Project' to complete the course of one's chosen subject.

With due information to the Institute and subsequent approval by the Dean, Faculty of Wildlife Sciences, the candidates would be engaged by the faculty members in the mutually agreed projects/cell activities.

4. ELIGIBILITY

Candidates who have completed or pursuing graduate/post graduate degrees and other equivalent or higher studies in recognized colleges, universities and institutions of higher learning can opt to be a volunteer. Educational qualifications may be relaxed in special cases at the sole discretion of Director WII.

5. DURATION

Minimum one month, extendable up to six months.

6. NUMBER OF SEATS

The number of seats for the Volunteer Programme will be limited to a maximum of 6 positions per year (January to December). A faculty member may be allowed to engage not more than one volunteer in a given year (January to December).

7. APPLICATION & SELECTION PROCEDURES

Interested candidates shall apply in the prescribed format **(Annexure–I)** through the concerned WII faculty members for necessary approval from Dean, Faculty of Wildlife Sciences. The selected candidates will be informed by the concerned Faculty regarding the terms & conditions and duration of affiliation.

8. ACCESS TO FACILITY

The candidates engaged as volunteer shall not be provided access to any of the Institute's facilities, except the library for consultation. In special case the candidate shall be provided limited access to other facilities such as laboratory, library, Computer & GIS, duly approved by the Dean, Faculty of Wildlife Sciences, as may be deemed necessary or justified by the concerned supervisor. In such cases, the candidate will be charged Rs. 3000/- as Access Fee.

9. ACCOMMODATION

No hostel accommodation will be provided to the volunteers in the Institute's campus.

10. EQUIPMENT

The volunteers shall not be issued any laboratory/field equipment by the Institute.

11. MEDICAL AND INSURANCE FACILITIES

WII will not be responsible for any casualty/mishap including any type of accidents and resultant death or injury to body or any type of loss of property etc. to the candidate while involved in the volunteer activities or during tour/transit. The Institute will not entertain any medical claim or will not extent any medical facility to the volunteers and it is advised that such candidates obtain their individual insurances (life, accident and medical) to cover any exigencies.

12. FACILITATION

Candidates engaged for any specified research projects/cell activities shall be guided by the concerned faculty members and any facilitation in the field and in the laboratory will be carried out by the faculty members with due information to the Dean, Faculty of Wildlife Sciences.

13. FOREIGN CANDIDATES

The candidate along with the application should submit a letter of request and recommendation from the Dean/Head of the Department/Registrar/Principal stating the purpose and the duration of Volunteer affiliation at WII.

Foreign candidates will have to arrange on their own the grant of appropriate research/academic visa for travel and stay while in India. Wherever necessary the WII will act as facilitator only. Once the Institute has conveyed its approval to the candidate for the proposed admission, the candidate can travel to WII, Dehradun on his/her cost. For affiliation, approval of the Dean, FWS will be required. The candidate needs to submit copies of his travel documents along with the form for affiliation as volunteer (Annexure 1). She/he will have liaison with Local Intelligence Unit as per the rules of the Government of India. In all other respect; the rules and regulations as stipulated in the case of Indian Nationals will also be applicable to visiting foreign nationals.

14. CONDUCT

The conduct of the candidates in the campus as well as in field must always be orderly and dignified. Candidates must abide by the rules and regulations of the Institute and concerned field organizations at all times.

15. SAVING AND REPEAL

The Director, WII reserves the rights to modify, alter, delete, amend or add any of the rules and regulations contained herein. The Director, WII may terminate the volunteer association of a candidate at any time, if he/she is found defaulter in any rules/regulations of the Institute.

16. DATA POLICY

The data generated during the volunteer program will be the property of Wildlife Institute of India. The volunteer will have to seek permission of the concerned faculty before publishing any scientific/popular articles and give due credits to all concerned.
