#### Eligibility criteria

Subject Matter Specialist should have good track record of academic/ service with proven contribution in the field of above-mentioned subject areas. Retired Forests Officers/ Scientist with field experience are encourage to apply. Age limit is 65 years, however, in exceptional cases, with approval of Director, WII, the age limit can be relaxed upto 70 years.

### GENERAL TERMS & CONDITIONS

1. The approved empanelled SMS list will be valid for the period of three years and depending on the Institute's need, the SMS will be engaged for specific time period.
2. The emolument of SMS would be based on honorarium of Rs. 5,000/- per day for maximum of 120 days in a Financial Year (FY) and no more than 15 days per calendar month.
3. Institute Internal Screening Committee has set to shortlist SMS for empanelling in the

pool of SMS list and the shortlisting of the SMS will be done based on the subject relevance and length of experience in the relevant field. The shortlisted SMS list will be hosted in WII web site.
