Ms. B. Barathi has requested for information regarding shortlisting of candidates appeared for Wildlife Institute of India's qualifying written test on 05.05.2019 for XVII M.Sc. course in Wildlife Science.

Her specific queries were:

- a) Please furnish the category wise (Gen, OBC, SC and ST) cut off marks fixed for shortlisting candidates or PAT in the above written examination

The shortlisting of the candidates was decided based on the marks obtained by the students in the NET (National Entrance Test) examination. Accordingly, following number of candidates were shortlisted based on their marks scored in the NET:

General: 41 candidates (10 seats)

OBC: 20 candidates (5 seats)

SC: 12 candidates (3 seats)

ST: 4 candidates (1 seat)

Overall, a total of 77 candidates were shortlisted to be called for PAT. Following were the minimum cut off marks against each category:

General: 54.5/100

OBC: 52/100

SC: 42/100

ST: 51.5/100
