The Govt. have decided that the posts which were in the pre-revised scale of Rs. 6500-10500 as on 01.01.2006 and which were granted the normal replacement Grade Pay of Rs. 4200 in the PB-2, will be granted grade pay of Rs. 4600 in the pay band-2 corresponding to the pre-revised pay scale of Rs. 7450-11500 w.e.f. 01.01.2006.
