Reference to the RTI application by Shri. Prasad Khale, Dombivli (E) Mumbal, the following information are furnished as per the listed questions:

(3.i.1). With the approval and recommendation of National Tiger Conservation Authority (NTCA), Wildlife Institute of India (WII) has been requested to prepare a Landscape Management Plan (LMP) by National Water Development Agency (NWDA). Only the proposal has been submitted and the preparation of LMP will be taken up after explicit approval of Ministry of Environment, Forest & Climate Change, Government of India, along with necessary funding support. Thus, the preparation is yet to begin and no copy is available.
