Sub: Compliance with RTI ACT by Wildlife Division- Reg.

At the outset, my profound apologies for encroaching upon your most valuable and precious time.

It is with great pain, I wish to draw your kind attention that I had earlier submitted two RTI applications to the Wildlife Division MOEF, one dt 24-11-2014 and the second dt. 23-02-2015 and in both instances, they very casually sent me an evasive negative reply stating that "Information not available". Now I need to send a third one (Original RTI application enclosed herewith for onward transmission) but I am afraid I may yet again receive the same diplomatic answer i.e " information not available" from them. Hence this appeal for intervention.

Hon'ble Sir, I had earlier requested for a copy of Annual Action Plan (AAP)1991-1992, of Wild life Divn. But they replied they could not locate it . Hence I am giving a clue where it should be available. The Animal Welfare Division (AWD) is an offshoot of Wildlife Division , having been created as per AAP 1991-92 of Wildlife Division. Hence if they look into file "Establishment of AWD", the Annual Action Plan 1991-92 should certainly be available. This file may be available either with WL Dn. or AWD. Please give suitable directive that a copy of AAP 1991-92 be furnished to me as per my RTI application dt.24-11-2014. Similarly the other information sought should be available with the WL Dn. in the WII file Only a genuine search need to be made.

Under the above circumstances, I am approaching your good offices to kindly intervene in the matter and to issue suitable directives to the Wildlife Division not to repeat the usual readymade reply "information not available" but to make a sincere search from their records and to furnish me the necessary information (for all my 3 application for which I have paid the necessary fees.) within the stipulated time and also for reporting the action taken to the PMO.

Hence the correspondence should be available in your files/ records

In this connection, it is requested, under the proviso of 2(f) of the RTI Act, 2005 to furnish me the following xerox copies as required.

1. The Wildlife Division had conveyed during 1994-96 the MOEF approval to the WII to switch over from the CPF to pension scheme. Please provide me a copy of the permission letter of MOEF.
2. Earlier to this, when did the WII submit their pension proposals to the MOEF ? Please provide me a Xerox copy of the forwarding letter of WII received by you .
3. The Rule / Order of the Dept of P & P W or the Min. of. Finance under which the MOEF granted permission to the WII Please send me a copy of the Govt. Order.
4. Whether the MOEF sent the WII pension proposal to the Ministry of Finance for their approval / concurrence? If so , a copy of the approval note of the Dept. of Exp may also be furnished.

I am sending you a DD for Rs.50 towards application fees and Xerox copies as required.
