essential qualifications for candidates. Otherwise she might have availed the 5 years of age relaxation (provided in the advertisement for all Employees of Wildlife Institute of India/ Central and State Government/ Autonomous Bodies/Government Universities up to 5 years to those who have not rendered less than three years of continuous regular service in such departments).

But based on the Supreme court order contractual staff/employee cannot avail the upper age limit relaxation of 5 years provided to permanent Government employees.

Unfortunately, Ms Vishnupriya Kolipakam has been a contractual employee of the Wildlife Institute since the past 3 years i.e. from (2015-2018). WII Contractual employee rules also doesnot mention of age relaxation granted to anybody.
