The information provided by the Institute through above referred letter in incomplete unsatisfactory and confusing. The reasons are as below:-

- A. The copy of supply order No.WII/ADM/STR 2011-12/53/65 dated 28.07.2011 for Rs.56,180/= at page No. 7 &13 are the same.
- B. The copy of the bill No.67125 dated 03/08/2011 at page No.10 & 17 are the same.
- C. The sanction order no. WII/ADM/STR/2011-12/053 dated 03/08/2011 for Rs.56,180/= at page No.11 & 19 are same.
- D. The copy of the proforma Invoice No.8727 dated 02/08/2011 for Rs.56,180 /= at page 14 &18 are same.
- E. The copy of Note Sheet and approval of competent authority at page No.15 & its back side, page No. 22 &23, Page No.26 &27 are same.
- F. The copy of voucher prepared by Sh. V. Gopalacharyulu at page 16 & 24 are same.
- G. The information provided vide page No. 8, 9 & 12 were not requested by the undersigned.

Thus 13 Pages are extra and the charges of Rs.26/= have been taken from the undersigned, which is not just and proper. This is the financial loss to the undersigned also.

H. The copy of indent for purchase of equipments are also not provided, so it is not known that what was the requirement.

I. Only one supply order No. WII/ADM/STR/2011-12/53/65 dated 28/07/2011 for Rs.56,180/= for the purchase of two chest freezer and two voltage stabilizer is provided. But the payments have been made for 4 chest Freezer and 4 Voltage stabilizer kindly inform the actual number of Purchase.

J. The copy of the stock register of central store where the entry of the equipments have been made is also not provided.

K. The location of the equipments, where the same are being utilized is also not provided.

2. The copy of the requisition slip for vehicle hiring, copy of the prior approval of the competent authority for vehicle hiring, information regarding year of Vehicle registration is also not provided.

You must be aware that after my RTI application Rs.56,180/= have been received in the Institute Account.

You are requested to provide the above Information's as early as possible. These Information's may be in the benefit of the Institute.
