Sir,

With reference to the above cited RTI application and reply thereon, it is stated that the information provided in incomplete, irrelevant, unsatisfactory and misleading. Also supply of unnecessary photocopies is causing huge financial loss. The para-wise details of information found incomplete, irrelevant to the cause, unsatisfactory and misleading information is as follows:

1. That as per para 17 of Terms & conditions of Office order no. A/2-1/2007-WII, dated 1st April 2015, wherein it is stated that "You will be covered by WII Employee Provident Fund Trust Rules.....", the para-2 of your RTI reply states that "WII has its own Employee Contributory Provident Fund Rules and provisions of the Employee Provident Fund being regulated by EPFO and are not applicable on the Institute". In view of the above, Annexure-1 provided under para 1 of your reply is not satisfactory and is irrelevant.

Photocopies charges paid for Annexure-1 are unjustified and caused financial loss.

2. That as per para 2 of information sought under RTI on approval of the Employees' Provident Fund Organisation (EPFO), Dehradun, for implementation of WII's EPF Trust Rules at WII, no information was provided.

3. That, no information was provided on date of sanction and date of implementation of WII's EPF Trust Rules for contractual employees at WII, as per para 3 of the desired information under the RTI application.

4. That, CPIO was unable to provide any information on details of the EPF Account of individual contractual employees at WII (if any) as per para 5 of the requested information under the RTI.
5. That, as per para 6, information on monthly EPF contribution for the month of March 2016 of all contractual engages at WII covered under the grant-in-aid funds/NMSHE/UNESCO C2C/BCRLIP/KSLCDI and/or any other externally funded project/activity/cell was sought under the RTI but your response states 'Not applicable'. In such event of non-applicability of any provision, providing Annexure-2 containing 231 pages is irrelevant to the information desired, not justified and lead to unnecessary cost.
6. In para 7, information was sought about the initial date of joining and consolidate emoluments of contractual employee at WII in a tabular shape to save the papers and conserve environment, but unnecessary photocopies which is not relevant and not containing required information has been provided as Annexure - 3.

In view of the above, you are requested to kindly provide relevant information as desired and refund the deposited amount of Rs. 528/-, as the photocopies provided are irrelevant, unnecessary and has duplication of information in most of the replies.
