

4. Whether the WII is receiving funds from the Ministry for disbursing Pension to the retirees. If so, the amounts received in each year during the period 2002- 2014 may please be furnished.
5. Please send me Xerox copies of the letters/correspondence exchanged between the WII and the Ministry (i.e. your letters to them and their replies) on Pension scheme only from 5<sup>th</sup> August 2012 to December 2014 uptill now. (Enclosures not required)
6. Copy of WII letter to the Ministry requesting for the Cabinet note and the Ministry's reply stating that they will prepare the Cabinet Note
7. Please mention the date/month in which the directly recruited staff gave their written option for switching over to the Pension Scheme.
8. Please also send a copy of WII's internal Office Note put up in May 1994 to your Head of the Institution i.e. Director/Competent Authority for getting their approval to adopt/implement the Pension scheme with effect from May 1994, in accordance with WII Pension resolution.
9. Earlier, I had sent a DD of Rs50/-. There may be a balance of Rs.30/-. Now I am enclosing a DD of Rs.50/-, Thus a total of Rs.80/- will be available towards my 2<sup>nd</sup> RTI application.
